



BLACK PEARL 2026

ROULETTE TOURNAMENT RULES

A. GENERAL

1. The Black Pearl 2026 Roulette Tournament ("**the Tournament**") is exclusive to qualifying MVG Members, who are at least 18 years of age, who are not excluded from gambling activities or who have not been refused entry to Sun International casinos or SunBet (online). Exclusions and refusal of entries imposed during the Tournament will preclude participation.
2. The Tournament will be hosted from 21 August 2026 to 15 November 2026. ("**Tournament Period**") The earning period will commence on the gaming day of 21 August 2026 and will terminate at 06h00 on calendar day of 14 September 2026 (i.e. gaming day of 13 September 2026). Unit elimination heats will be held from 16 October – 31 October 2026. The Grand Finale will be held from 13-15 November 2026 at Sun City.
3. Sun International (South Africa) Limited or the Participating Entities (collectively "Sun International") reserves the right of admission to the Tournament, and the right to postpone or terminate the Tournament at any stage without prior notification and compensation.
4. These Tournament rules are the official rules that are applicable and will supersede any version or document containing similar content that is distributed, published or displayed.
5. To be eligible to participate, MVG Members ("**Participants**") must register on the electronic platform for free at any of the participating Sun International entities listed below ("**Participating Entities**") at the designated VIP or MVG Desks or online for SunBet.
6. Participating Entities: Boardwalk, Carnival City, GrandWest, Meropa, Sibaya, Sun City, Time Square, Wild Coast Sun, and SunBet (online).
7. During the Tournament Period Participants will earn Roulette points whilst playing Roulette table games in land-based casinos and Live Dealer roulette games on SunBet (online) on an accumulative basis across all participating entities. To qualify to participate in the Tournament, a participant must earn a minimum of **100 Roulette Tables Points** during the Tournament Period.
8. Participants who have earned a minimum of **1000 Roulette Tables Points** in land-based casinos during the Tournament Period will be entered into a Wild Card draw at the respective qualifying

Sun International entity during the unit heat event, before the unit tournament heats and seats draw, where one winner from each casino will be selected and will advance directly to the quarter final at Sun City. In the event there are no Wild Card qualifiers, the unit heats and seats draw will continue.

9. After 06h00 on 14 September 2026 (calendar day) and following internal verifications each entity's leader board will be consolidated to determine the Top Points Earner from each participating entity. Each of these unique Participants will automatically secure a seat in the in semi-final round at the group finale at Sun City. Where a Participant has qualified as the Top Unit Points Earner at multiple Participating Entities, he/she will be elected once for a seat in the group semi-finals using the leaderboard where he/she first qualified as Top Points Earner and he/she will relinquish the other seats. The participants who were in second position on the other leaderboards (where the Top Points Earner was also ranked in first position) will assume Top Points Earner at those respective Participating Entities.

10. At the quarter final at the Grand Finale a Participant will only be permitted one seat per heat. All other seats held by the Participant in the same quarter final heat will be forfeited without the option of a proxy nomination or any form of compensation.
11. An eligible Participant will be permitted only one seat in the group semi-finals in the Grand Finale. Where a Participant obtains more than one seat in the group semi-finals then he/she must relinquish the additional seat(s) without the option of a proxy nomination. The Top Points Earners qualify for a seat in semi-final heat at the Grand Finale, and do not participate in any unit heats.
12. Seat positions will be allocated by way of a random draw. Seat allocations cannot be changed. Participants must be present at the draw for seat allocations.
13. Participants must be physically present to participate. Seats are not transferable, and Participants must be present at least 15 minutes before the actual start of any heat, quarter final, semi-final or final where the game rules and relevant protocols will be explained in addition to the written game rules and protocols. Participants who are not present at least 15 minutes before the actual start of any heat, quarter final, semi-final or final will forfeit their seats. In such instances the games concerned will continue without the full quota of Participants.
14. At each heat and quarter final, Participants will be issued with R5 000 no-value tournament chips. At the semi-finals and finals Participants will be issued with R10 000 no-value tournament chips. Tournament chips are not redeemable for any consideration. No re-buys are permitted, and

Participants are not permitted to introduce additional tournament chips at any stage. Any attempts to introduce additional tournament chips will result in immediate disqualification from the Tournament. Tournament chips cannot be pooled or transferred to other Participants.

15. Tournament chips must always remain in the designated chip area on the table and in sight of other Participants. All tournament chips must be returned to the casino after each stage. Tournament chips remain the property of Sun International.
16. Coaching of Participants is not permitted and may result in disqualification at the discretion of the tournament director. Participants play for themselves, and no alliances may be formed between Participants.
17. Under no circumstances will any bets be accepted after the dealer has called "No More Bets".
18. The Participant with the highest chip count at the end of 10 spins will be regarded as the winner of the respective heat and will advance to the next stage of the tournament. The grand finale final will be played over 10 spins.
19. The leaderboard rankings are preliminary outcomes. The ranking of Participants at each respective stage will be confirmed by the entity concerned after it has verified the same by 10h00 the following day. In the event of any malfunction of the system used for the automatic ranking on the leader boards, the respective casino will manually rank the Participants by relying on the Roulette tables points earned over the period as recorded by that casino.
20. Prizes will be paid in line with the advertised prize schedule. Prizes are not transferable.
21. The tournament calendar and prizes will be advertised through the advertising channels used for this tournament. Dates and times are subject to change without prior notice. Participants must take care to ensure that they are aware of the correct dates and times.
22. By participating in this tournament, it is deemed that Participants agree to be bound by the tournament rules and furthermore give consent to the Participating Entities to display their personal information on the leader boards.
23. All disputes during the Tournament shall be referred to the respective Tournament Directors for resolution. The decision of the Tournament Director concerned will be final and binding and no further correspondence will be entered into. In the Western Cape, all gambling-related disputes may be referred to the Western Cape Gambling and Racing Board.
24. Travel arrangements for the respective Participants and their partners to travel Sun City must be finalized within the deadlines set by Sun International, failing which affected Participants and their partners will be liable for their own travel costs.
25. Participants and their partners will be liable for costs incurred for any changes made to travel and accommodation bookings, where applicable. Also, the afore-going persons will be liable for all costs in respect of goods or services that are not included in the travel and accommodation bookings.

26. In the event of any clause, provision, term, or condition of these tournament rules be found to not be enforceable or is invalid by any law or is waived by election of Sun International, such clause, provision, term or condition shall be severed from these rules to the extent that it shall not invalidate the remaining rules. Should any of the Participating Entities be lenient in applying these rules, it does not mean that they have waived any of their rights or are limited in apply the rule strictly in the future.

B. CASINO HEATS/ELIMINATION ROUNDS – GAME RULES

- i. Each Participant will receive R5 000 in tournament chips at the start of the heat.
- ii. Table limits of R25 minimum to R500 maximum on a number will apply.
- iii. Participants will be given 60 seconds to place their bets; all bets will be placed prior to the dealer spinning the ball.
- iv. A heat will consist of 10 spins.
- v. No call bets will be permitted.
- vi. No even chance, columns or dozen bets will be accepted.
- vii. Participants must bet on every spin.
- viii. A chip count will be done on the 9th spin.
- ix. On the 9th and 10th spin – 90 seconds will be allocated for betting.
- x. On the final spin and before the commencement of the 90 seconds to place bets, each Participant will be allowed a secret bet consisting of a single number and its splits to a maximum of R500 per split and straight up (this must be in equal units i.e. 17 and the splits by R100). The Participant will record and sign for their bet in secret and away from the table but must pay for the bet in front of the other Participants. The Dealer will check that the Participant has advanced the correct amount for the bet and will hand the secret bet to the Inspector. The secret bets will be opened and placed by the dealer on completion of the final spin and after the layout has been cleared.
- xi. When a part of a losing bet placed on the layout is over the table limit, the part that is over the limit will be forfeited and not returned to the Participant. Should such a bet be a winning bet, the bet will be paid up to the table maximum and the part over the table maximum will also be forfeited.
- xii. The Participant with the highest chip count will be declared the winner of the heat; in the event of only one Participant being left in the game that Participant will be declared the winner.
- xiii. In the event of a tie, a “Spin off” will occur whereby the tied Participants will have one “Sudden Death Spin” including a secret bet to determine the winner of the heat.
- xiv. If the Participants are once again tied, then they will continue with the “Sudden Death” spins and secret bets until a winner is determined.
- xv. Under no circumstances will any bets be accepted after the dealer has announced “No More Bets”

- xvi. The winner of each unit heat will be awarded a prize of R10,000 in non-negotiable chips.

GROUP FINALS

- The group finals will be hosted at Sun City, NorthWest on the weekend of 13-15 November 2026. The finals will comprise of a quarter finals, semi-finals and final round.
- The 80 eligible Participants will compete in an elimination format tournament in the group quarter finals.
- 16 Winners from the group quarter finals and the unit top Points Earners Players will commence to the semi-final.
- 5 Winners from the semi-final will commence to the final.
- The Participant with the highest chip count at the end of each heat will advance to the next stage of the tournament as per the structure below:

- The quarter finals, semi-finals and finals will be conducted on the same mechanics and format as the unit heats specified in section B, with changes to the following rules:
 - In the semi-finals and finals, the Participants will receive a starting stack of R10,000 in Tournament chips to play.
- There will be a heat and seat draw for each of the quarter finals, semi-final and final rounds.

Bonus Event (Sponsored by SunBet)

- During the group semi-final and final rounds, a bonus event will be introduced whereby Participants will draw a number from 0 to 36 ("Bonus Number"), prior to the start of the semi-finals or if the bonus is not won in the semi-final heats, prior to the start of the final round.
- The first Participant's Bonus Number that has resulted in double or triple spins in succession of each other during the semi-finals or final round will win additional prize money:

- **R50,000** for a double spin
 - **R500,000** for a triple spin
- The bonus event is a once off event and will not be offered passed the concluding spin of the semi-final or final. The bonus prizes cannot be won during additional spins to break a tie.
- Bonus prizes are limited to one in each category and will be won by the first Participant that achieves a double or treble spin respectively.

C. MAIN PRIZE POOL

1. The total main cash prize pool for the Tournament final round is valued at R2.5 million as per below:

- Should 2 or more finalists exit the final table on the same spin the relevant prize money applicable to those finishing positions will be added together and divided equally.
